High Visibility Warning Waistcoat, CLASS 3 visible areas of fluorescent ORANGE background and retroreflective tape. Two horizontal bands around torso and vertical braces over each shoulder including 2 bands on arms of retroreflective tape.



Do not wash in biological powder. Warm machine wash. Cold rinse. Short spin. Do not wring. Rinse well. Do not tumble dry.




The chromaticity and retro reflective properties have been tested after 25 washing cycles only.
